ŽELIM POSTATI ČLAN / I WANT TO BECOME A MEMBER OF SPINS

1. S podpisom te pristopne izjave sprejemam statut in program ZSSS ter Sindikata profesionalnih igralcev nogometa Slovenije (SPINS), v katerega se včlanjujem. Članarino sindikatu bom plačeval/-a v obliki denarnega nakazila ali odtegovanja od plače (direktna bremenitev/trajnik) v skladu z zakonom, kolektivno pogodbo in akti sindikata SPINS.
2. Z namenom učinkovitejšega individualnega in kolektivnega varstva ter uveljavljanja pravic in interesov v zvezi s komercialnim izkoriščanjem moje javne podobe, s podpisom te pristopne izjave neodplačno prenašam na SPINS oziroma SPINS-u podeljujem, v spodaj dogovorjenem obsegu, vse pravice oziroma upravičenja za komercialno izkoriščanje moje javne podobe ter v tem smislu SPINS-u dovoljujem, da ta skladno s svojimi cilji delovanja in v dogovorjenem obsegu:
 - a.) v svojem imenu in za svoj račun (razen če je za posamezen primer dogovorjeno drugače) komercialno izkorišča in tretjim osebam dovoljuje ali prepoveduje komercialno izkoriščati mojo javno podobo;
 - b.) upravlja s pravicami oziroma upravičenji, ki so predmet te izjave, jih prenaša na tretje osebe, kolikor je to zakonsko dopustno, ter v ta namen v svojem imenu in za svoj račun (razen če je za posamezen primer dogovorjeno drugače) sklepa pravne posle s tretjimi osebam.
3. Prenos oziroma podelitev pravic iz 2. odstavka velja v naslednjem obsegu:
 - za uporabo moje podobe ali dela podobe v kakršni koli obliki (npr. v obliki video posnetka, fotografije, risbe, slike, karikature, računalniškega lika, tridimenzionalnega objekta), osebnega imena, vzdevka, glasu, podpisa ali katerega koli drugega atributa osebnosti, osebnega podatka, informacije ali predmeta, na podlagi katerega me je mogoče neposredno ali posredno identificirati oziroma izkoriščati mojo javno podobo;
 - v zvezi z nastopi ali kakršnimi koli drugimi mojimi aktivnostmi, bodisi individualnimi bodisi v okviru kolektiva (npr. kot del ekipe ali druge skupine posameznikov), v nogometni reprezentanci Slovenije ali izven nje;
 - za kakršne koli vsaj delno komercialne namene in ne glede na vrsto uporabljenega medija oziroma platforme;
 - teritorialno neomejeno;
 - za čas veljavnosti mojega članstva v sindikatu SPINS.
4. Prenos oziroma podelitev pravic iz 2. odstavka učinkuje izključno (ekskluzivno), kar za potrebe te izjave pomeni, da:
 - a.) je SPINS, razen v primeru mojega izrecnega pisnega nasprotovanja v posameznem primeru, poleg mene edini, ki sme komercialno izkoriščati mojo javno podobo ali takšno komercialno izkoriščanje dovoliti ali prepovedati kateri koli tretji osebi, z omejitvijo, da ta pravica SPINS-a ne posega v moje morebitne druge predhodne izključne (ekskluzivne) dogovore;
 - b.) brez predhodnega pisnega soglasja SPINS-a ne smem nobeni tretji osebi dovoliti komercialno izkoriščati svoje javne podobe oziroma na tretjo osebo prenesti ali ji podeliti pravic za komercialno izkoriščanje svoje javne podobe. Strinjam se, da dovoljenje, prenos ali podelitev pravic v nasprotju s prejšnjim stavkom nima pravnega učinka.
5. SPINS-u posebej dovoljujem objavo in uporabo mojega imena in priimka, datuma in kraja rojstva, državljanstva, fotografije in telesnih značilnosti (višina, teža, spol) na spletnih straneh sindikata SPINS in SŠS ter v spletnih ali drugih aplikacijah in platformah, ustvarjenih ali uporabljenih s strani SPINS-a in SŠS.

Dovoljujem, da se moji osebni podatki zbirajo za vodenje točne evidence članstva, spremljanje gibanja članstva, plačevanja članarine, izobraževanja, nudenja pravne pomoči, izplačevanja solidarnostnih pomoči, spremljanja podatkov o funkcijah, vodenja zavarovanj in kreditov ter izdelave statističnih analiz, v skladu z akti sindikata SPINS in ZSSS.

1. By signing this statement of affiliation, I accept the Statutes and the programme of the Association of Free Trade Unions of Slovenia (ZSSS) and of the Union of Professional Football Players of Slovenia (SPINS), of which I am becoming a member. I will pay my membership fee due to the union in the form of a money transfer or deduction from my salary (direct debit/standing order) in accordance with the law, the collective agreement and the SPINS union's acts.

2. In order to protect and enforce my rights and interests in relation to the commercial exploitation of my public image more effectively, individually and collectively, by signing this statement of affiliation, I hereby gratuitously transfer to SPINS or grant to SPINS, to the extent agreed below, all rights or entitlements for the commercial exploitation of my public image and, to that end, I authorise SPINS, in accordance with its objectives and to the extent agreed, to:

- a.) commercially exploit and permit or prohibit third parties from commercially exploiting my public image in its own name and on its own account (unless otherwise agreed on a case-by-case basis);
- b.) administer the rights or entitlements which are the subject of this statement, transfer them to third parties to the extent legally permissible and, for this purpose, enter into legal transactions with third parties in its own name and on its own account (unless otherwise agreed on a case-by-case basis).

(3) The transfer or grant of rights referred to in Paragraph 2 shall apply to the following extent:

- For the use of my image (likeness) or part of an image in any form (e.g. video, photograph, drawing, painting, caricature, computer character, three-dimensional object), personal name, nickname, voice, signature or any other attribute of personality, personal data, information or object on the basis of which I can be identified or my public image can be exploited, directly or indirectly;
- In connection with my performances or any other activities, whether individual or collective (e.g. as part of a team or other group of individuals), in or outside the Slovenian national football team;
- For any at least partly commercial purposes and regardless of the type of media or platform used;
- Unrestricted territorially;
- For the duration of my membership in SPINS.

4. The transfer or grant of the rights referred to in Paragraph 2 shall have exclusive effect, which for the purposes of this statement means that:

- (a.) SPINS shall, except in the event of my express written objection in a particular case, be the only person other than myself that may commercially exploit my public image or permit or prohibit such commercial exploitation by any third party, provided that this right of SPINS shall be without prejudice to any other prior exclusive arrangements I may have;
- b.) I may not, without the prior written consent of SPINS, permit any third party to commercially exploit my public image or transfer or grant to any third party any rights to commercially exploit my public image. I agree that any permission, transfer or grant of rights contrary to the preceding sentence shall have no legal effect.

5. I specifically authorise SPINS to publish and use my full name, date and place of birth, nationality, photograph and physical characteristics (height, weight, gender) on the SPINS and Slovenian Trade Union of Athletes (SŠS) websites and in online or other applications and platforms created or used by SPINS and Slovenian Trade Union of Athletes (SŠS).

I authorise the collection of my personal data for the purposes of keeping accurate membership records, monitoring membership trends, payment of membership fees, education, legal assistance, solidarity grants, monitoring of function data, insurance and credit management and statistical analysis, in accordance with the SPINS and the Slovenian Association of Free Trade Unions (ZSSS).

I authorise my personal data to be collected for the purpose of information (mark as appropriate).

This declaration replaces any previously signed statement of affiliation to SPINS that I may have signed.
